



RENTAL AGREEMENT

Aim of Quad Rental by Quady na Peṭli to the Hirer(s) and Passengers

These vehicles are intended for leisure use only in the Bieszczady area only. By signing the rental agreement, you are agreeing to all statements and to the declaration.

Quady na Peṭli's Responsibilities

1. At the time of renting out a Quad, **Quady na Peṭli** will ensure that the vehicle is in good condition, the vehicle has its registration documents, the vehicle has one set of keys, the vehicle is technically operational, the vehicle is clean and has a full tank of petrol.
2. All vehicles are legally registered for 2 people and have third party liability insurance. A GPS tracker is fitted to each Quad.
3. **Quady na Peṭli** and the **Hirer** will do a walkaround check of the vehicle before the rental starts, and the **Hirer** is obliged to sign the check sheet, which will document any issues with the vehicle before rental and will record all equipment included with the vehicle.
4. All personal details of **Hirers** will be stored in accordance with EU Data Protection regulations.
5. Helmets will be supplied to all drivers and passengers.
6. **Quady na Peṭli** will explain to the **Hirer** how to use the vehicle, and will explain the procedure for reporting any unforeseen issues with the Quad during the rental period.

The Hirer's Responsibilities

1. *Driving Licence and ID*
All **Hirers** should have a legal, valid driving license (Cat. B or B1). If the passenger also has a legal, valid driving licence and wishes to drive the vehicle at any time during the rental period, driving licence details of the passenger will also be required. In the event of damage (accident, collision, flooding, flooding), and / or in the event of injuries of the driver and passenger caused by not complying with the Highway Code, Criminal Law and Civil Law, the driver at the time of the incident will be held responsible. All **Hirers** should have a separate ID card as a document confirming their identity.
2. *Signed Declaration*
All **Hirers** are obliged to sign the declaration at the bottom of this Rental Agreement, in which they state that they rent the vehicle at their own risk and responsibility. All **Hirers** must state that in the event of health damage to themselves or any passengers, no **Hirer** will not demand compensation from **Quady na Peṭli**, and that the **Hirer** bears full responsibility for any damage to the vehicle and third parties.
3. *Condition of the Vehicle before Hire*
All **Hirers** are obliged to familiarize themselves with the condition and operation of the Quad before the rental period starts. Any concerns regarding the condition of the vehicle should be reported to **Quady na Peṭli** before or during the rental period. In the event of a technical failure of the Quad, the **Hirer** is obliged to secure the Quad and immediately inform **Quady na Peṭli** about the condition of the Quad and the **Hirer's whereabouts.**
4. *Driving on Public Roads*
The vehicle can only be driven on public roads by the **Hirer** or **Hirers** who have signed this rental agreement. When driving on public roads, each driver and passenger is required to wear a protective helmet at all times. The registration document must be available at all times for inspection by the authorities. Minors and / or passengers without a Driving Licence are prohibited at all times from driving on public roads. The **Hirer** is obliged to pay any fines or other penalties resulting from violation of the law while on public roads.

5. *Driving Off Road*

When driving on non-public roads, dirt roads and forest areas, the **Hirer** undertakes to take responsibility for complying with all regulations that are in force in these areas. Any consequences resulting from breaking rules and regulations regarding these areas shall be borne solely by the **Hirer**. Over 16s may use a vehicle off-road only in the presence of their parents or legal guardians, and under their full responsibility. The **Hirer** is obliged to pay any fines or other penalties resulting from violation of the law while off-road.

6. *Alcohol and Drugs*

All **Hirers** are obliged to absolutely refrain from consuming alcohol or other intoxicants before or while driving the vehicle.

7. *Loss or Damage*

The **Hirer** assumes full material responsibility in the event of any accident, loss or damage to the vehicle not covered by third party liability insurance, regardless of fault. The **Hirer** will be charged the full cost for any loss of equipment or for any repair to the vehicle. The **Hirer** must not leave documents and vehicle keys in the vehicle if the vehicle is left unattended. Loss of keys will be charged at PLN 500. Loss of the registration certificate will be charged at PLN 500.

8. *Use of the Vehicle*

The Quad is rented to the **Hirer** for tourism and leisure use only. Jumps and wading in water or mud with a depth of more than 20 cm is prohibited. The vehicle rented to the **Hirer** may not be used to transport people or goods in the form of subletting, to tow other vehicles, to transport items that may damage the vehicle or exceed its carrying capacity, in races, rallies or sports competitions, or contrary to customs, road and other regulations.

9. *Return of the Vehicle*

The **Hirer** undertakes to return the vehicle on time, undamaged and fully equipped. Any damage or loss will be charged at cost price. Cleaning of the vehicle at the end of the rental is included in the price, however very dirty vehicles will have to be cleaned before a final walkaround check can be done, and the **Hirer** will need to stay with the vehicle until cleaning and checks are complete. If the vehicle is not returned within the time specified in the contract, the **Hirer** is obliged to cover all costs resulting from this situation.

10. *Fuel*

For rentals longer than 1 hour, there will be a fuel surcharge. The amount charged will depend on the amount of petrol used. If the **Hirer** prefers to return the quad with a full tank of petrol, no charge will be made.

Declaration

I have read all the Rental Regulations and have understood them.

I agree to rent the vehicle at my own risk and responsibility.

In the event of health damage to myself or any passengers either before, during or subsequent to the rental period, I, the **Hirer**, agree not to demand compensation from **Quady na Pełti**.

I, the **Hirer**, bear full responsibility for any damage to the vehicle and / or third parties as set out in the Rental Agreement above.
